Cancelation Policy:

ALL RESERVATIONS: depart per scheduled time. Any late arrivals, no shows or change in the amount of Jet Skis reserved will NOT be refunded. If you wish to re-schedule or cancel your reservation, you must call in advance (Hour notice stated below). If not done within that time frame you will lose your reservation deposit (NO REFUNDS) and the possibility of re-scheduling for another date.

JET SKI RENTALS: RESCHEDULE OR CANCELLATION POLICY MUST BE 48 HOURS IN ADVANCE.

SAME DAY RESERVATIONS FOR ANY SERVICE STATED ABOVE: If you are making a reservation for the same day, or out of our policy stated above, client accepts there are NO REFUNDS, NO CANCELLATIONS, NO RE-SCHEDULING.

SAME DAY=FINAL SALE!!

Weather Conditions: We will give a CALL-TEXT or e-mail to all our customers, providing a rescheduling opportunity. A full refund can be issued if you can't make it for another date. In the case that it is a small passing shower, we wait a few minutes (usually around 15 min) and go out once it stops raining.

Please take into account that we will make this decision based on weather in OUR AREA. If it is raining someplace else or the weather is just cloudy, it doesn't mean that you can cancel your ride. In this case, you will lose your reservation deposit and our regular cancellation policy stated above applies to the reservation.

The undersigned has requested a rental of a personal watercraft device or jet ski. The undersigned affirmatively states he or she has viewed or will view materials relating to the safe use and operation of the equipment prior to operating the equipment. The undersigned will not operate the equipment in an unsafe manner and is familiar with the "rules of the road" relating to the safe and proper use of the equipment to be rented.

The undersigned understands he or she, and not the company, will be responsible for any injuries or mishaps arising out of the use of the equipment and the undersigned understands the lessor is not responsible for the misuse or unsafe operation of the equipment by the undersigned or actions of other people on the lake who might cause a mishap.

The undersigned will be responsible for any wrecks, accidents, collisions or other mishaps that occur during the rental, and the undersigned will be solely liable for any damages that occur if such mishap occurs during the rental time either to the renter, a passenger or anyone else the renter should happen to contact during the rental period.

I. DISCLAIMER

Rental Policy

Policy& requirements

- Everyone must bring a Valid picture ID.
- Must be 18 or Older to Rent
- Anyone under 18 needs to have a Parent or Legal Guardian accompany them on the jet ski (minimum age of 6 to ride the jet ski).
- Maximum weight per Jet Ski: 350 lbs.

- Anyone born on or after Jan 1, 1982 is required to have a Boaters Education Card
- If you do not have a valid boaters safety course card, you can study for a 10-question test which can be administered at the rental site. You must pass this prior to you renting the jet ski.
- Must complete Online registration and sign all documents/ liability forms that have been emailed to you 48 HOURS prior to your reserved time. **WE CAN NOT ALLOW YOU TO OPERATE THE MACHINES WITHOUT THESE BEING COMPLETED**
- Please arrive 45 minutes prior to your reservation time. We do this to have you ready to leave at your requested time.
- Only bring ID/wallet please do not bring big purses/bags etc.
- A Phone or watch is recommended to keep track of the time
- Driver is responsible for all damages to the skis
- Insurance on skis are available!
